



## Call for submissions

### Special Issue on “Companies”

March 18, 2019

The journal *Economie et Statistique / Economics and Statistics* is launching a call for projects for a special issue bringing together various works around the theme of “companies”.

Under this broad entry point, the journal targets microeconomic approaches to companies considered as a “population”, of which the characteristics and behaviours are to be analyzed.

Submissions may address issues along four main lines:

1. Companies’ Profiles and Demographics: mapping the productive structure, territorial and geographical location, heterogeneity of legal forms, concentration, restructuring, sectoral perspectives, major developments since early 2000s
2. Industrial Economics: subcontracting, networks, location and location strategies, innovation strategies, globalization, global business chains, exposure to competition
3. Organization and Management: internal organization, governance, management styles, leaders, parity and diversity, succession
4. Companies and the Society: corporate social responsibility, companies and the environment, perception and image of companies

The journal welcomes original work on France or on other countries, as well as international comparisons.

Interested authors are invited to **submit, by May 13, 2019 at the latest, a two-page project** outlining the research question, method(s), source(s), main expected results and possible interpretations. Submissions, in English or French, should be sent to [redaction-ecostat@insee.fr](mailto:redaction-ecostat@insee.fr). They will be reviewed by the Scientific Committee; particular attention will be paid to the precision of the question(s) addressed and the methodological quality of the projects.

The decision on which projects are selected will be notified by June 17, 2019.

Full papers will be expected by January 31, 2020, and be submitted to the standard review process of the journal (double-blind peer review). The publication of this special issue is planned for early 2021.
